# CONSTITUTION

## Article I.

### NAME

The name of this organization shall be Rotary Club of Bangor, Maine. (Member of Rotary International.)

## Article II.

### OBJECTS

*Section 1.* The objects of Rotary are to encourage and foster the ideal of service as a basis of worthy enterprise and, in particular, to encourage and foster:

1. The development of acquaintance as an opportunity for service;

2. High ethical standards in business and professions; the recognition of the worthiness of all useful occupations; and the dignifying by each Rotarian of his occupation as an opportunity to serve society;

3. The application of the ideal of service by every Rotarian to his personal, business and community life;

4. The advancement of international understanding, good will, and peace through a world fellowship of business and professional men united in the ideal of service.

## Article III.

### MEMBERSHIP

*Section 1.* Kinds. There may be four kinds of membership, namely: active, honorary, past service, and senior active.

*Section 2.* Qualifications — Active Membership. Adult male persons of good character and good business reputation—

engaged as proprietor, partner, corporate officer, or manager, of any worthy and recognized business;

or holding an important position in an executive capacity with discretionary authority in any worthy and recognized business;

or acting as the local agent or branch representative of any worthy and recognized business, having entire charge of such agency or branch in an executive capacity; and
