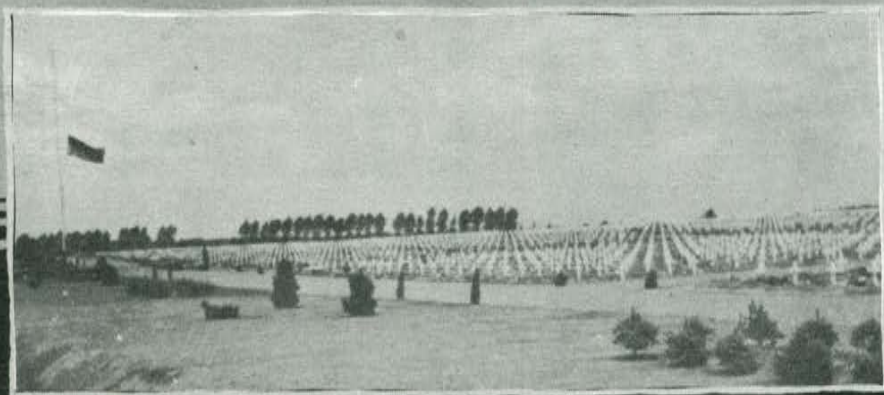

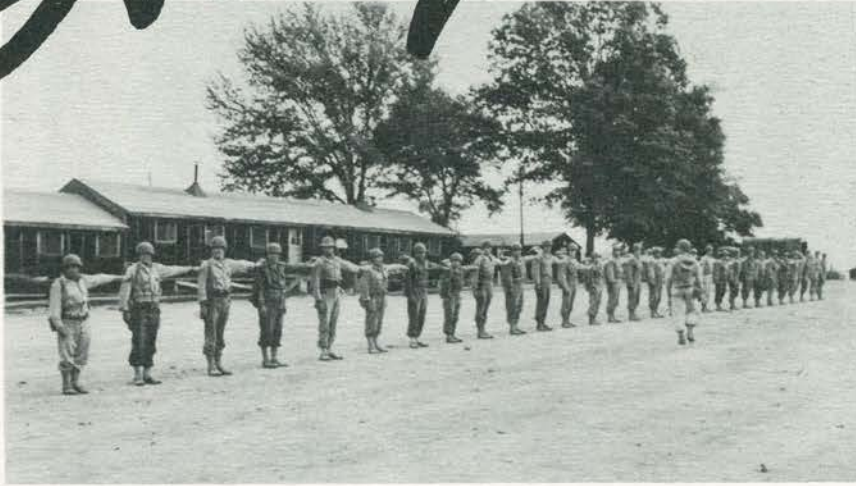

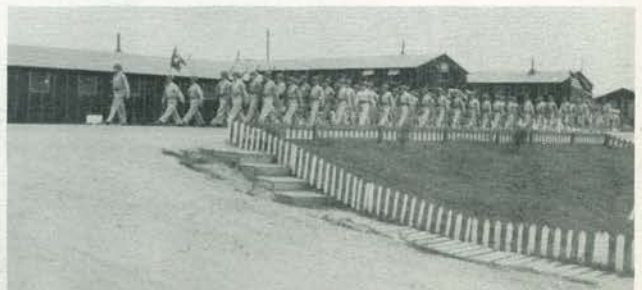
# THE *Story* OF THE 1288th



THE history of the 1288th Engineer Combat Battalion has been well recorded on film. The history of some of the scenes and buildings pictured on the following pages dates back to the Medieval and even Roman eras while in others you see the settings so familiar as the backdrops for the greatest epic of all times, World War II, in which you, the members of the 1288th, had a hand in the making of history.

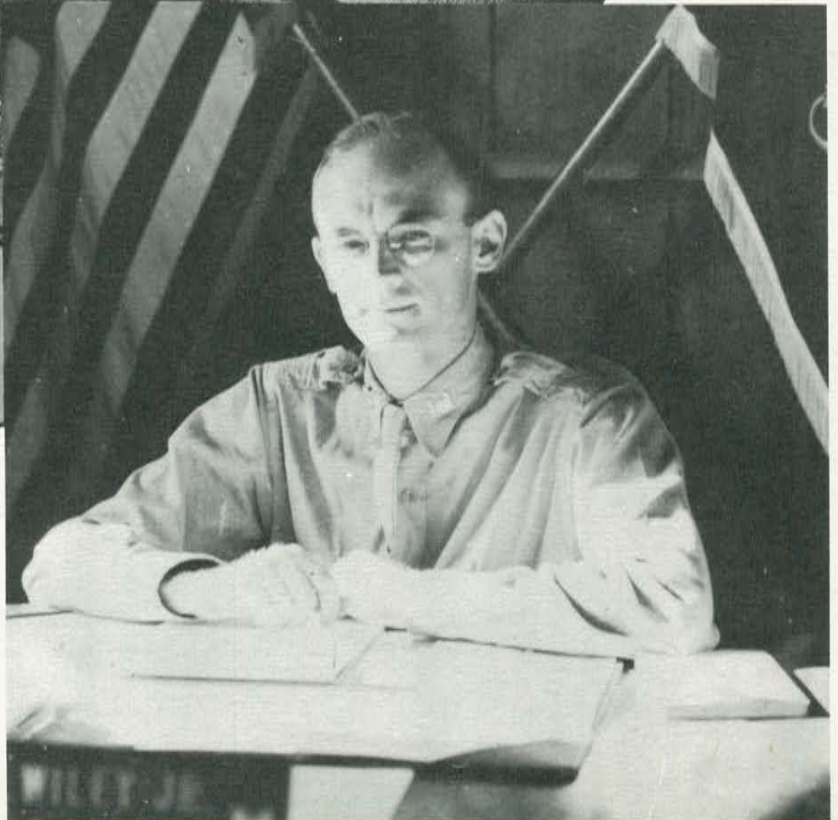

# Activation to Embarkation



**T**HE 1288th Engineer Combat Battalion was activated at Camp Van Dorn, Mississippi, on May 10, 1944 under the command of Lt. Col. Oval H. Robinson. The full battalion complement of officers had formerly served in the 156th Engineer Combat Battalion in California and the enlisted cadre was from the 258th Engineer Combat Battalion. The day after activation Lt. Col. Robinson was transferred on orders of The War Department to another battalion scheduled for immediate movement overseas and Major Richard B. Wiley assumed command of the 1288th. On June 15 Lt. Col. Frederick P. DeLemos was assigned to the battalion and remained as the commanding officer throughout its entire history.

Those early days at Camp Van Dorn were typical of what Winston Churchill meant when he characterized the war as being one of "Blood, Sweat and Tears" at least that part about "sweat". The battalion toiled through the cadre training, pre-ITP, and most of the regular ITP period in temperatures near the 100 mark each day. Mine laying, mine field removing, bridge building, close combat, rifle range firing, bayonet drill, map reading, engineer reconnaissance, demolitions, and a multitude of other subjects imprinted themselves on everyone's mind as a sort of montage impression of the things that we would be called upon to do when the chips were down.

Welcome relief from the grind were the Saturday football games at L. S. U. Stadium in Baton Rouge and the trips to Dixie Springs for swimming.

Early in October the 1288th was alerted for overseas movement and after about a month of intensive work on POM requirements, training tests, packing, and show down inspections, the Battalion left

Camp Van Dorn for the New York Port of Embarkation on 21 November 1944.

The 60-hour day coach ride from Van Dorn to the Port will always be remembered as a fine example of the inconveniences of travel. With great unkinking of muscles and straightening of vertebrae the Battalion expanded from the train on Friday the 24th of November at Camp Shanks, New York. Although it smacked a little of fattening the calf the Thanksgiving dinner served at the Camp immediately after unloading was probably the most sumptuous ever served in the army. After finishing last minute preparations and plowing through a maze of red tape all personnel enjoyed passes to New York city until Friday the 1st of December when the Battalion was alerted for embarkation. Saturday was passed by card playing and marking time awaiting the order to entrain for the trip to the pier.

The Battalion left Camp Shanks at 1830, Sunday, and after a twenty five minute train ride transferred to the 42nd Street Ferry on the New Jersey side to cross to New York directly onto the pier at 50th street. The Dutch owned, former luxury liner, Nieuw Amsterdam was berthed on one side of the pier and the Queen Mary on the other. The band played stirring music and the Red Cross girls smiled stirring smiles and gave us doughnuts which we held in our teeth since both hands were required for carrying the "minimum" equipment as we staggered up the gangplank of the Nieuw Amsterdam.

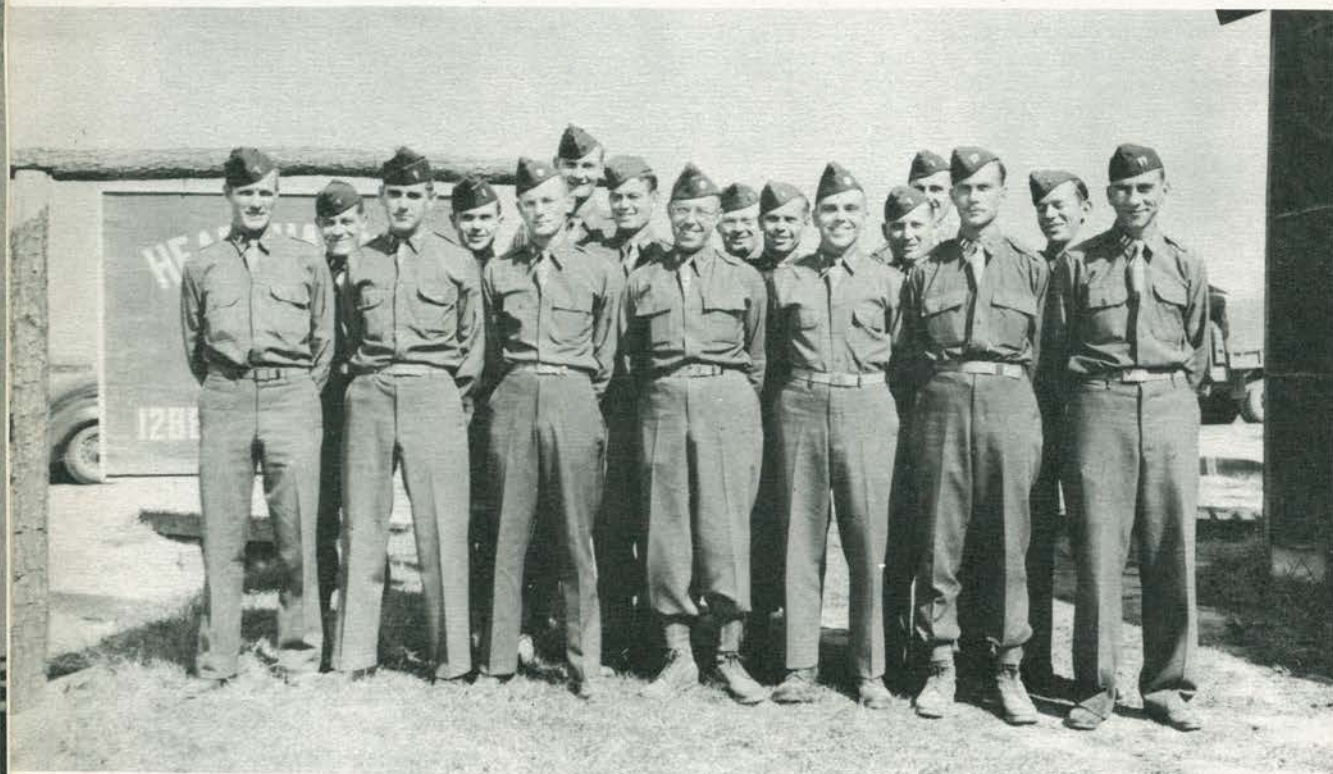

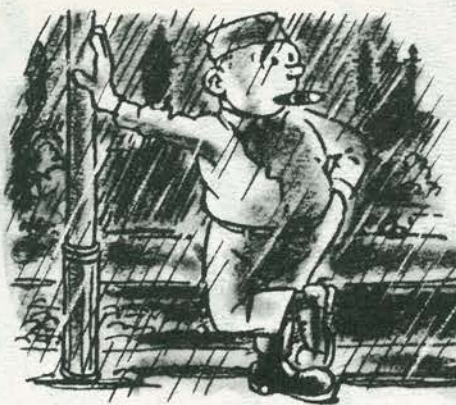


# PACKING *for* OVERSEAS



The Nieuw Amsterdam, 36,287 gross tons, flagship of the Holland-America Line, carried the 1288th Engineer Combat Battalion from New York to Gurock, Scotland for overseas duty.





# LIFE in the United Kingdom

**G**UROCK, Scotland was as beautiful as a travelogue in technicolor as we approached it gliding slowly up the Firth of Clyde on the afternoon of the 12th of December. The voyage had taken nine days and had carried us as far south as Florida, across to a position near Africa, up the coast of Spain, and into the Irish Sea. The second and third days had been the roughest in the experience of the Nieuw Amsterdam as a troop transport.

Landing by lighter the next morning at Greenock, a few miles up the Clyde from Gurock, the Battalion entrained for the cold ride down into England. At 0800 on the 14th we arrived at Chipping Norton, Oxfordshire, which was to be our home station while in the United Kingdom. Situated in the heart of the Cotswold district of England its pastoral beauty was in cheerful relief to the bleak blackout train ride through Scotland.

Billets were immediately established in an odd assortment of buildings. Battalion Headquarters and "A" Company set up at Greystone Manor, a mile and a quarter south of town, "B" and "C" Companies at the Brewery in town, and H&S Company in an old three story affair on London Road.

Engineer training was begun at once only to be interrupted on January 8th when an intensive four week period of infantry training was put into effect because of the serious threat of the Battle of the Bulge which was then in progress on the continent. The emergency subsided however, and the Battalion returned to engineer training on February 6th.

A fine opportunity for seeing rural England was provided for everyone since the training called for several weeks of Bailey Bridge construction at Wallingford on the Thames river, firing at Tilshead on the Salisbury Plain near prehistoric Stonehenge, and an assault crossing problem on The Severn near Gloucester. There was also a detail of about eighty men in London for several months building emer-

gency housing units for bombed-out families.

In addition to travels in the line of duty there were many passes to London, Stratford on Avon, Oxford, Cambridge, and a few even got up to Edinburgh and Glasgow.

On April 9th the Battalion moved out of Chipping Norton for the last time in motor convoy headed for Weymouth which was the Port of Embarkation for the trip across the Channel.

At Le Havre, France, the Battalion saw for the first time a completely destroyed city. The first contingent of the 1288th landed on the 11th of April having crossed the Channel on an LCT. The second group aboard a smaller LCI had been delayed because of rough weather. The vehicles were driven off of the LCT directly onto the beach as there were no docks or piers left in Le Havre. Re-forming into convoy order amid the ruins, the first serial moved out immediately for Camp Twenty Grand approximately 50 miles up the Seine near the village of Duclair. Several days were spent there in final equipping for combat operations, and on Saturday the 14th of April the Battalion moved out in motor convoy—destination, Germany.

The route took us through Rouen, Amiens, Cambrai, Mons, Liege, Aachen, and finally to Julich where we were to establish our headquarters. One glance at Julich, however, was sufficient to convince us that it was no place to quarter a battalion. The odor that pervaded the air was the only reminder that people had once lived in that pile of rubble when it had been a city. The advance party which had preceded the Battalion had done its work well and we were escorted by them to the city of Viersen about 30 miles to the north where very comfortable quarters were established in Kaisers Kaffee Geschäft, the home office of a chain of German grocery stores.

Having arrived in Viersen on the evening of the 15th the 1288th was immediately assigned the mission of support of the 94th Infantry Division then disposed along the west bank of the Rhine opposite the German forces of the "Ruhr Pocket" in the vicinity of Dusseldorf. The first jobs undertaken were minesweeping of road and maintenance of the main supply routes. At the same time the Reconnaissance section was reconnoitering the Rhine between Bonn and Dusseldorf for suitable sites for construction of a Floating Bailey Bridge.

On Wednesday the 18th the Battalion received orders to build a Floating Bailey at Grimlinghausen, three miles south of Dusseldorf and work was begun that day. "A" and "C" Companies were to build the bridge and "B" Company was assigned the tough job of clearing the "S" mines from the extensive minefield on the east bank. Working twenty four hours a day the battalion completed the 1500 foot long bridge on the twenty third only to see it knocked out by a large cargo barge swept downstream by the swift Rhine current. All attempts to sink the barge by 40 mm. and small arms fire before it struck the bridge failed, so everyone put their shoulders to the task of building the bridge anew.

1st Lt. Robert S. Day received the Bronze Star for his work in saving a large part of the bridge. On May 1st the bridge was open for traffic again and this time to stay as one of the important arteries for the evacuation of American troops and returning French and Belgians.

On the 5th of May the Battalion moved further south to assume responsibility for a new sector. The CP was moved to Euskirchen sixty miles to the south. A second change of orders on the 7th sent the 1288th to Aachen to take over engineer responsibility for the entire Regierensbezerk Aachen, an area of about 1450 square miles. The battalion remained there for about five weeks doing maintenance of the routes of evacuation and conducting an exhaustive reconnaissance and inventory of materials which could be salvaged from the wrecked factories and warehouses for reconstruction work necessary to the occupation forces.

In the course of the operations out of Aachen opportunity was afforded for trips into Holland, Belgium, France, and Luxembourg. Many photographs of these countries appear on the following pages.

On June 16th the 1288th was ordered to Baumholder near Trier to await orders for movement to Arles Staging Area in southern France as the first leg of its redeployment to the south Pacific.

# Visiting France and the trip HOME



ON June 22nd 1945 the 1288th left Baumholder on the four-day motor convoy that took it through Saarbrücken, Sarreguemines, Nancy, Neufchâteau, Langres, Dijon, Lyon, Valence, Avignon, and into the staging area near Arles.

From the twenty fifth of June until departure from the continent the men had little to do except sightsee, swim in the Mediterranean, avail themselves of trips either to the Riviera, Lourdes, or Paris, and of course occasionally suffer those sand storms known as "Mistral" which blew down the Rhine Valley threatening to take our tent city apart. The inconveniences of living in the barren windswept desert that was The Arles Staging Area was well compensated for by the opportunities afforded to visit such places as the town of Arles where the Romans had built a Coliseum 50 years before Christ. The Coliseum is still in use and was visited by many of the men on evenings when bull fights were held there. Also located in Arles is one of the most beautiful of Roman churches, St. Trophimes, and the ruins of a Roman amphitheater. The painter Van Gogh did many of his best works in Arles. About equal distance on the other side of camp was Salon, birthplace of Nostradamus.

Twenty five miles to the north was Avignon, where the Papal Palace, residence of the Popes from 1309 until 1377, is still standing and was visited by many of the men of the 1288th.

Other places of interest were Nîmes, Montpellier, Carcassonne, and Lourdes farther to the west.

The great port city of Marseille, being only forty miles from camp, was visited frequently by men on pass.

It was with mingled feelings of relief at getting out of the staging area and regret at leaving colorful Southern France that the battalion embarked on the troopship USS General Richardson at Marseille on August 10th for a destination in the Philippines.

All was smooth sailing as the General Richardson plied its way through the Straits of Gibraltar, past "The Rock" and into the Atlantic headed for the Panama Canal.

On 14th August, three and a half days at sea, the astounding news of the final victory over Japan was announced to all aboard via the loud speaker system. The celebration had hardly subsided when it was announced on the following day that the General Richardson was on a new course headed for Boston.

Few will ever forget that occasion on the General Richardson and the gay reception as we steamed into Boston Harbor with the music from the reception boat competing with that of our own band and the blasts from many ships whistles.

After a whirlwind trip from the pier to Camp Myles Standish and after the reception center routine all personnel left for forty five days at home.

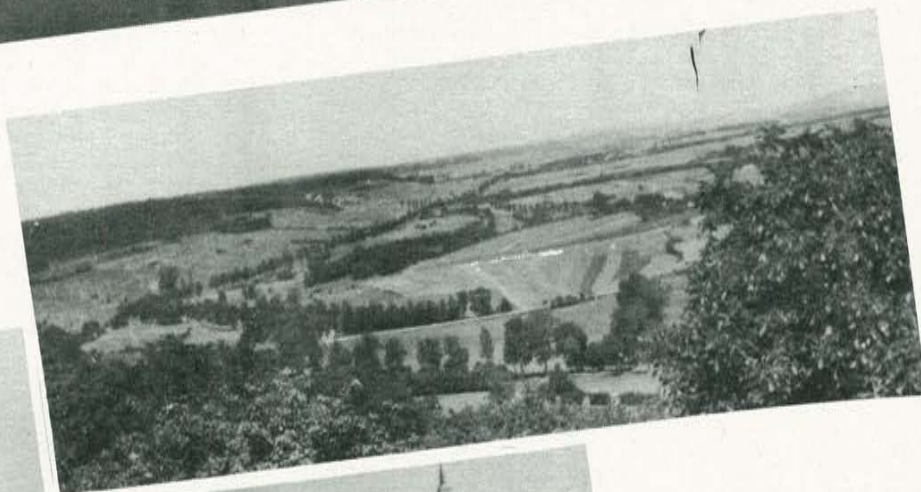
Reassembling at Camp Swift, Texas the battalion underwent a short period of training combining engineer subjects with those for "prospective civilians". Finally in January 1946 the history of the 1288th was brought to a close with the inactivation of the battalion at Camp Swift.
